OF THE PRESIDENT OF THE REPUBLIC OF AZERBAIJAN

On implementation of the Law of the Republic of Azerbaijan

"On Social Protection of the Forcibly Displaced Persons and Persons, equated with them"

In connection with of the Law of the Republic of Azerbaijan "On social protection of the forcibly displaced persons and persons, equated with them" coming into legal force and with the view to provide implementation of the law in question I hereby do enact:

1. To charge Cabinet of Ministers of the Republic of Azerbaijan within 1 month:

- to submit to the President of the Republic of Azerbaijan proposals of bringing of current legislative acts into compliance with the Law of the Republic of Azerbaijan "On social protection of the forcibly displaced persons and persons equated with them";

- to provide compliance of the legislative and normative acts adopted by the Cabinet of Ministers and Central Executive Authorities with the Law in question and to notify the President of the Republic of Azerbaijan;

- to approve the order of moving of forcibly displaced persons to inhabited, administrative, auxiliary and other buildings, available or possible to put in proper order for residing;

- in cases, specified by part II of article 5 of the Law to approve the order of resettlement of the forcibly displaced persons in other habitation sites and submit proposals on "appropriate executive bodies" to the President of the Republic of Azerbaijan, provided in the same part;

- to approve rules and conditions of allocation of land plots to forcibly displaced persons for agricultural activity, issue of loans and rendering assistance, provided in the article 6 of given Law;

- to approve the order of issuance of bank loans to the forcibly displaced persons, dealing with commercial and enterprenereal activity, provided in part 5 of article 7 of given Law;

- to approve rules of providing of forcibly displaced persons, provided in part I of article 9 of given Law, with one-time and regular financial aid, foodstuffs and industrial goods;

- to provide preparation and approval of the normative - legal acts on other problems in regard to powers of Cabinet of Ministers of the Republic of Azerbaijan on the basis of article 2 of the present Decree;

- to solve other problems arising from the Law of the Republic of Azerbaijan "On social protection of the forcibly displaced persons and persons, equated with them" within the framework of their authorities.

2. To determine, that:

- authorities "of appropriate executive bodies", provided in part I of article 5 of the Law of the Republic of Azerbaijan "On social protection of the forcibly displaced persons and persons, equated with them", shall be executed by Cabinet of Ministers of the Republic of Azerbaijan, State Committee on the refugees and forcibly displaced persons and local executive bodies within the framework of their activity

- authorities "of appropriate executive bodies", provided in article 6, part 5 of article 7, part I of article 9 and part 3 of article 10, shall be executed by Cabinet of Ministers of the Republic of Azerbaijan;

- authorities "of appropriate executive bodies", provided in part 1 and 3 of articles 7 of given Law, shall be executed by the Ministry of Labor and Social Protection of the population of the Republic of Azerbaijan and State Committee on the refugees and forcibly displaced persons;

- authorities "of appropriate executive bodies", provided in part II of article 9 of given Law, shall be executed by the Republican Commission on the International Humanitarian Aid ;

- authorities "of appropriate executive bodies", provided in part I of article 10 of given Law, shall be executed by the Ministry of Public health of the Republic of Azerbaijan;

- authorities of "appropriate executive bodies", provided in part I of article 11 of given Law, shall be executed by the Ministry of Education of the Republic of Azerbaijan;

- authorities "of appropriate executive bodies", provided in sentence 1 of article 12 of given Law, shall be executed by the State Committee of the Republic of Azerbaijan on the refugees and forcibly displaced persons, State Concern "Azeravtonaghiyyat" and local executive bodies;

- authorities "of appropriate executive bodies", provided in sentence 2 of article 12 of given Law, shall be executed by the State Committee on the refugees and forcibly displaced persons.
