Data is used for:

- Reapportionment at the federal level
- Drawing federal, state, county and city district lines
- Drawing school district boundaries
- Budget planning
- Forecasting future housing needs

- Targeting funds for people in poverty
- Targeting services for children and adults who speak other languages
- Forecasting future state and local transportation needs
- Planning for local public transportation
- Developing special programs for low income families
- Locating special needs populations
- Establishing emergency management programs and priorities
- Planning for hospitals, nursing homes, clinics and other health services
- Planning services for people with disabilities
- Developing public safety programs
- Urban planning

- Developing and attracting new businesses
- The distribution of \$200 billion in federal funds and more in state funding

Why Counties Should Be Involved

Counties should be actively involved in helping with the outcome of the year 2010 Census. Information from the short form provides vital data on income, size of households and race and ethnicity. The American Community Survey (ACS) which has an annual sample size of nearly 3 million, provides the demographic data that many counties need to plan for future growth, transportation, service delivery and welfare reform, and also provides the data used by many federal agencies for entitlement programs and allocations of federal funds. The table below displays just a few of the data elements and the agencies that use them.

Bedrooms, kitchen facilities, place of work, journey to work	DOE, HHS, HUD, DOC, DOJ, EPA, Fed Res, etc.
Year moved into unit, Hispanic origin, farm residence, shelter costs	EPA, HHS, HUD, DOJ, EEOC, USDA, DOEd, etc.
Ancestry, telephone in unit, grandparents as caregivers	DOJ, DOL, EEOC, HHS, HUD, etc.
