DATA NOTES

The ranks are for the largest 100 metropolitan areas, by population. Exports include goods and services and are estimated by production location; therefore, they do not match the U.S. Census Bureau's estimates of metropolitan exports, which reflect origin-of-movement. Exports exclude waste, scrap, used merchandise, goods returned to Canada, special classification provisions, re-exports, military transfers, government services, and expenditures of foreign embassies and international organizations in the United States. Top three losses/gains in exports, by value are in \$2010. Export growth rate, by value, is inflation-adjusted by industry.

Direct export-production jobs are jobs supported by exports in the industries producing the exported good or service. These are in the metropolitan area where the export is produced.

²Total export-supported jobs include direct export-production jobs as well as jobs supported by exports in the suppliers to the exporting industry, and in the case of goods exports, in the transportation and wholesale trade industries. Some portion of these jobs lies outside the metro area producing the exports and in other parts of the United States.
