





Argentine performance tended to be ahead the world and even the Emerging Economies ... according to Official Data




...but not according to independent estimates




Argentina has lost relative positions in total Latin American GDP




How is Inflation doing?







Argentina has lagged , even as in recent years it picked up (even with corrected data)




TFP Growth vs. TFP Level, Major Economies, 1990-2012





The education quality is low in spite of high average spending






Argentina's science graduation is low




Investment and Savings (10 year average)








GDP Growth rates: Past and projected




Gross Public Debt to GDP has declined, while that of the Advanced Countries Grows




Net Investment Position / GDP




Real Exchange Rate Depreciation (decline)


