李扬 中国社会科学院 副院长

李扬是中国社会科学院副院长,前央行货币政策委员会委员,产业金融研究基础学术委员会主席。李博士在经济领域享有极大的影响力。他也是国务院常务会议列席成员并参与中央重要的国内和国际金融经济问题决策与战略制定。李扬与许多国家以及国际金融组织如 IMF、世界银行、经合发展组织、亚洲开发银行的资深官员有着密切联系。李扬曾是哥伦比亚大学的访问教授,也在清华大学、北京大学等顶尖名校授课。



MARTIN INDYK 布鲁金斯学会 执行副主席

Martin Indyk 在结束自己巴以和谈特使的身份后于 2014年7月1日回归布鲁金斯学会并担任布鲁金斯学会执行副主席。在此之前,Indyk 曾在布鲁金斯学会担任副主席、外交政策项目主任,是布鲁金斯学会资深研究员和中东政策中心创始主任。他曾分别于 1995-1997 年和 2000-2001 年期间担任美国驻以色列大使。

刘亚伟是卡特中心中国项目主任。他作为卡特中心的一员,从 1997年至2011年长期观察中国乡村的基层选举,同时也关注尼 加拉瓜、秘鲁和中国台湾地区的选举,并且撰写了大量中国政治 发展、基层民主与中美关系的文章。刘亚伟著有《当代中国农村 治理与选举观摩丛书》、《德赛政治论丛》、《选举与治理》和 《奥巴马: 他将改变美国》等书。同时,他在国内报刊如《环球 时报》、《学习时报》和《中青报》等也发表了大量文章。

Martin S. Indyk is the Executive Vice President of the Brookings Institution, returned to Brookings in July 2014, after serving as the U.S. special envoy for the Israeli-Palestinian negotiations. Previously, Indyk was Vice President and Director of the Foreign Policy Program and a Senior Fellow and the Founding Director of the Center for Middle East Policy at Brookings. He served as U.S. Ambassador to Israel from 1995-1997 and from 2000-2001.
