BOOK PROJECT Taxation for Representation traces the role of tax policy in the advances and reversals of American

democracy. Just as it is essential to the initial development of representation, taxation shapes political developments when the bounds of representation are contested. Movements to expand suffrage have sought emancipatory taxation and public spending that would ensure a rough economic parity among American citizens and provide poor and marginalized people with the economic independence necessary for full political participation. The most powerful forces resisting taxation in America have also been the country's most anti-democratic elements; ready to support suffrage restrictions, malapportionment, minority rule, and sometimes direct intimidation and violence, to keep fiscal power in elite hands. Moreover, the same reactionary movements have also fought to undermine the state's fiscal powers where

they might threaten wealth, and to push tax responsibilities onto the marginalized.
