Amadou is an advisor to the Director of the IMF African Department with a focus on macro-financial and financial sector issues. In addition to leading IMF missions to Mauritius and the Seychelles, he is conducting research on financial sector issues relevant to Africa, including FinTech, correspondent banking relations, and macrofinancial linkages. Amadou is also a nonresident senior fellow at the Africa Growth Initiative (AGI) at the Brookings Institution which he was leading until January 2017. There he led policy and research work on macroeconomic and financial issues. His work on the Financing for Development agenda has been influential in global policy circles and he has provided expert advice to the African Development Bank, Making Finance Work for Africa, and the UN. Amadou is working on a book entitled "Africa through an economic lens."

Amadou has published in top academic and practitioner journals, including the *Journal of Banking & Finance, IMF Staff Papers, Journal of Fixed Income, Finance and Development, Journal of African Economies, and World Economics.* His policy work won the runner-up 2011 ICFR-Financial Times Prize for best research on financial regulation. He is a member of the Editorial Board of the *Revue d'Economie du Développement*, manages the *African Economic Research Consortium* Visiting Scholars program at the IMF, and has been a member of Ph.D. Thesis Committees at the Université d'Auvergne.

Amadou has presented his work at international conferences and central banks worldwide and has testified at the U.S. Congress. He has contributed to blogs, podcasts, radio and TV programs and was quoted in *The Financial Times*, *The Economist, The Wall Street Journal, The New York Times, The Los Angeles Times, The Washington Post, BBC, Bloomberg, Foreign Policy, El Pais, Les Echos, Il Sole, and O Globo.*

Prior to joining Brookings, Amadou has held a variety of positions at the IMF, covering more than 20 countries and all the financial crises since 1998. He served as Deputy Chief in the Monetary and Capital Markets Department where he worked on financial and capital markets stability and development missions in Africa, Asia, Europe, and Latin America. He also coordinated the IMF work on stress testing and financial surveillance tools and worked on financial regulation, supervision, and crisis management. At the IMF Institute for Capacity Development, he taught macroeconomics and finance courses to midand senior level staff from central banks and ministries of finance in Asia and Africa, as well as the IMF. He also worked on a project to set up a Trust Fund for capacity building in Africa. He also co-edited an IMF book on the management of natural resources wealth and has written speeches for the IMF Managing Director and the head of the Monetary and Capital Markets Department.

During the 1998 Asian crisis, Amadou monitored global capital markets participants, including investment banks, institutional investors, and hedge funds at the IMF's Research Department. Amadou then developed an expertise in assessing the stability of financial systems before moving to capital markets development in specific countries, including Islamic finance and sovereign debt management. He also worked on reserves management and helped develop the *Santiago Principles* for sovereign wealth funds.

Amadou holds a Ph.D. in Finance for McGill University and is a CFA charter holder as well as a Financial Risk Manager.
