How were first suburbs selected for our study?

- Used county-level geography
- They existed in 1950 as counties that were part of 1950 'standard metropolitan areas' (SMAs)
- County had to be contiguous with a center city that was ranked in the top 100 in 1950
- Data for the central city is not included if such existed within the county



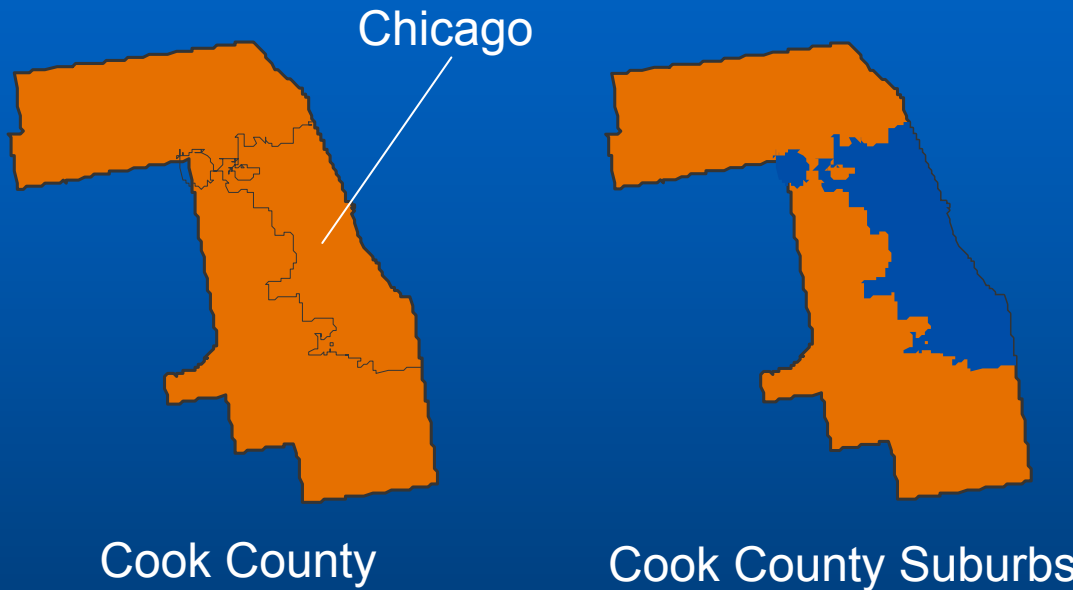

For example, in Cook County the first suburbs are defined as those outside (or excluding) Chicago

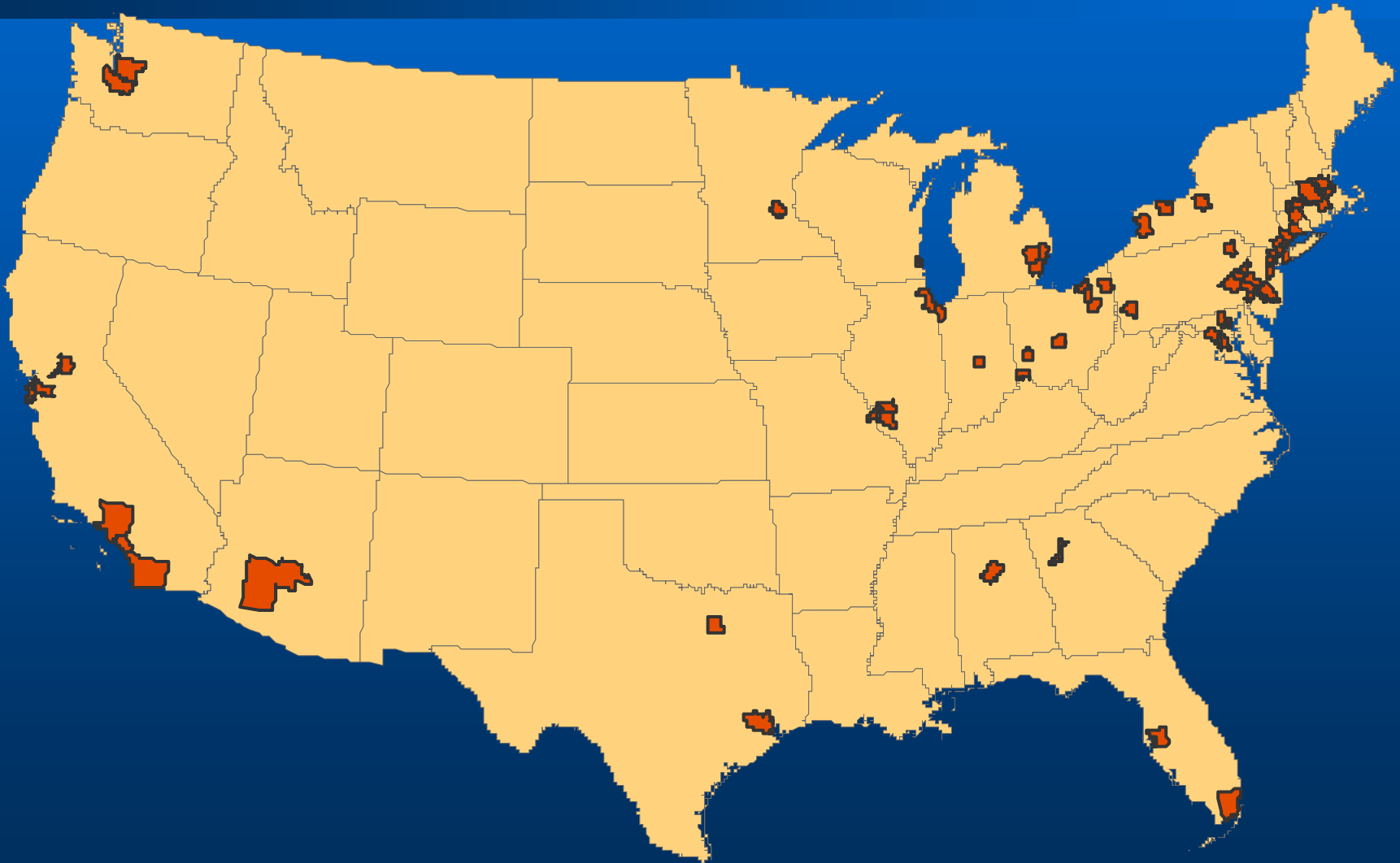

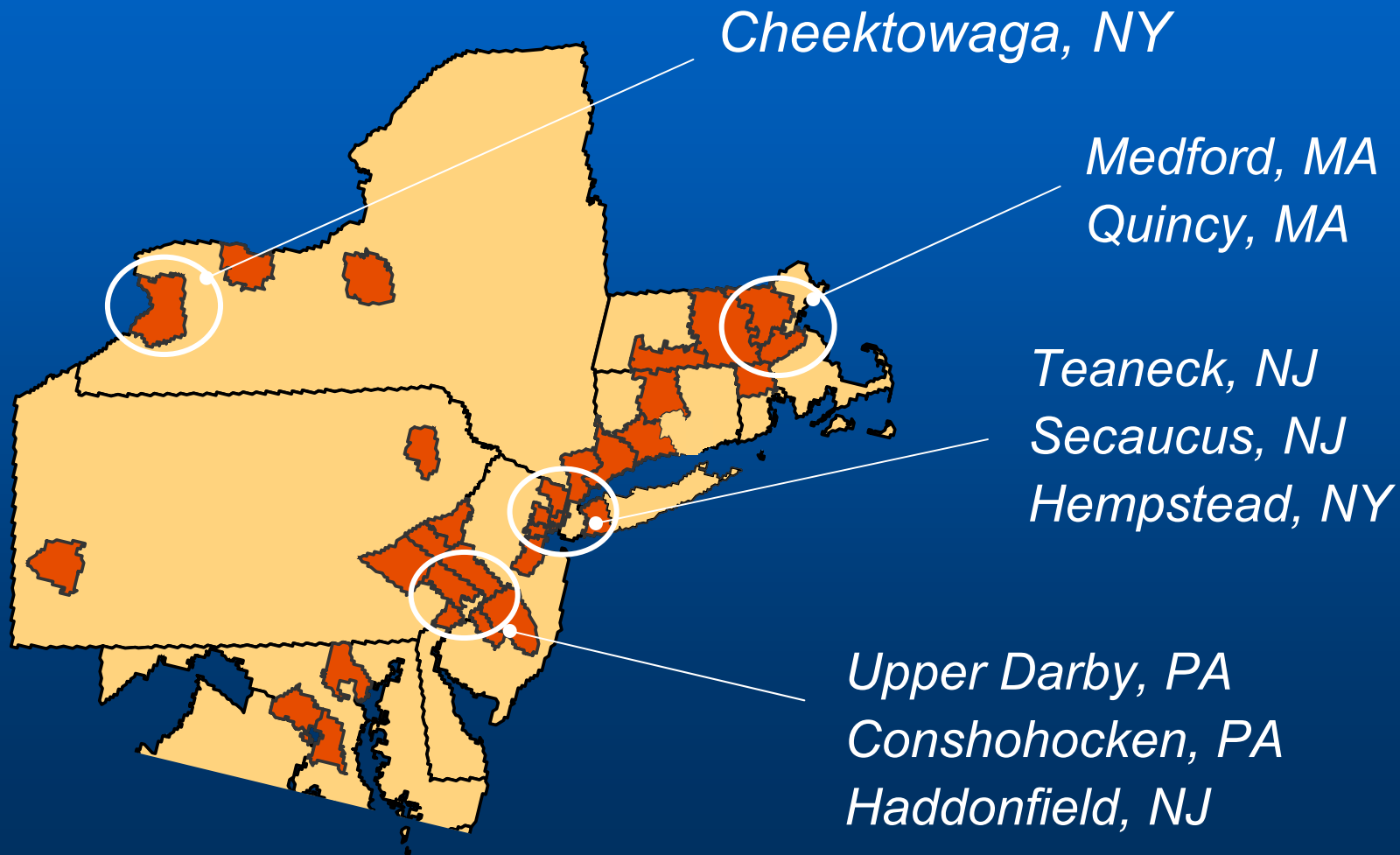

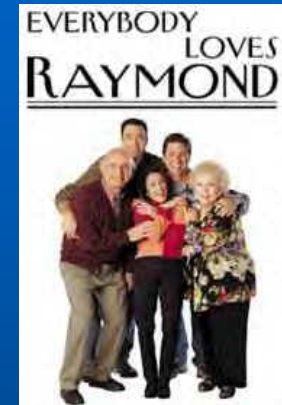

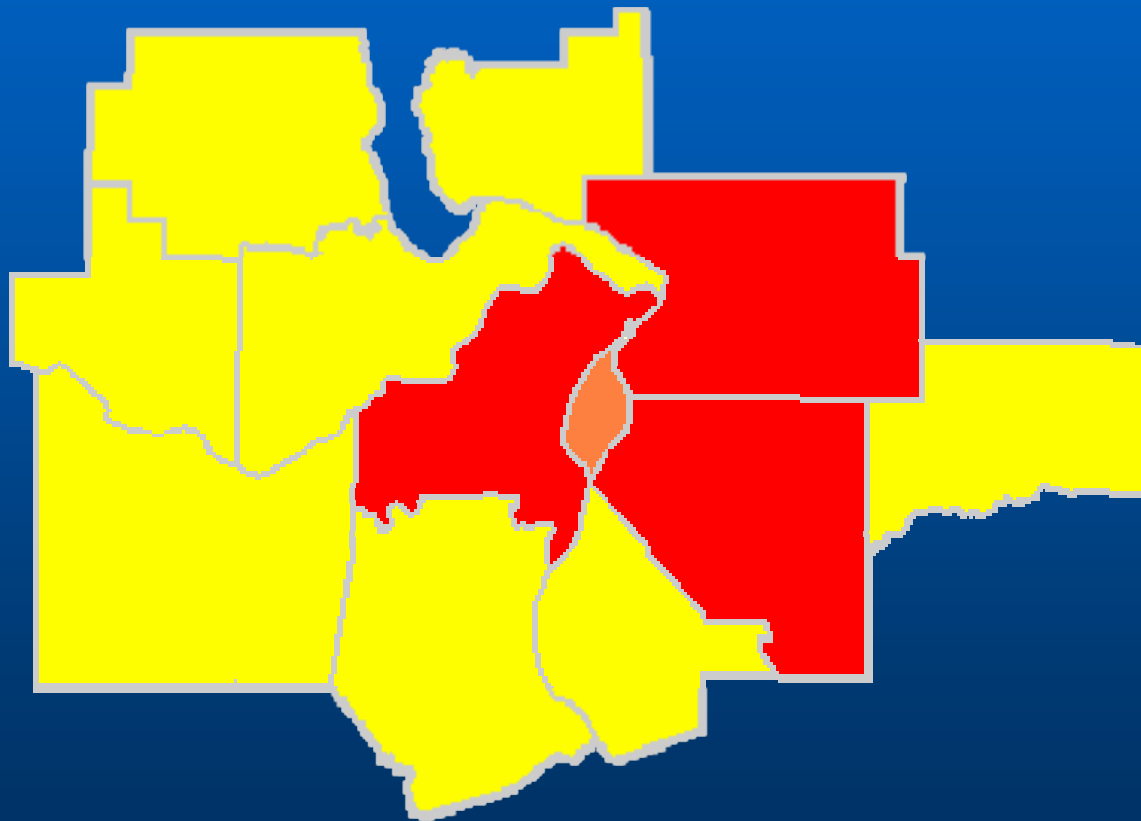

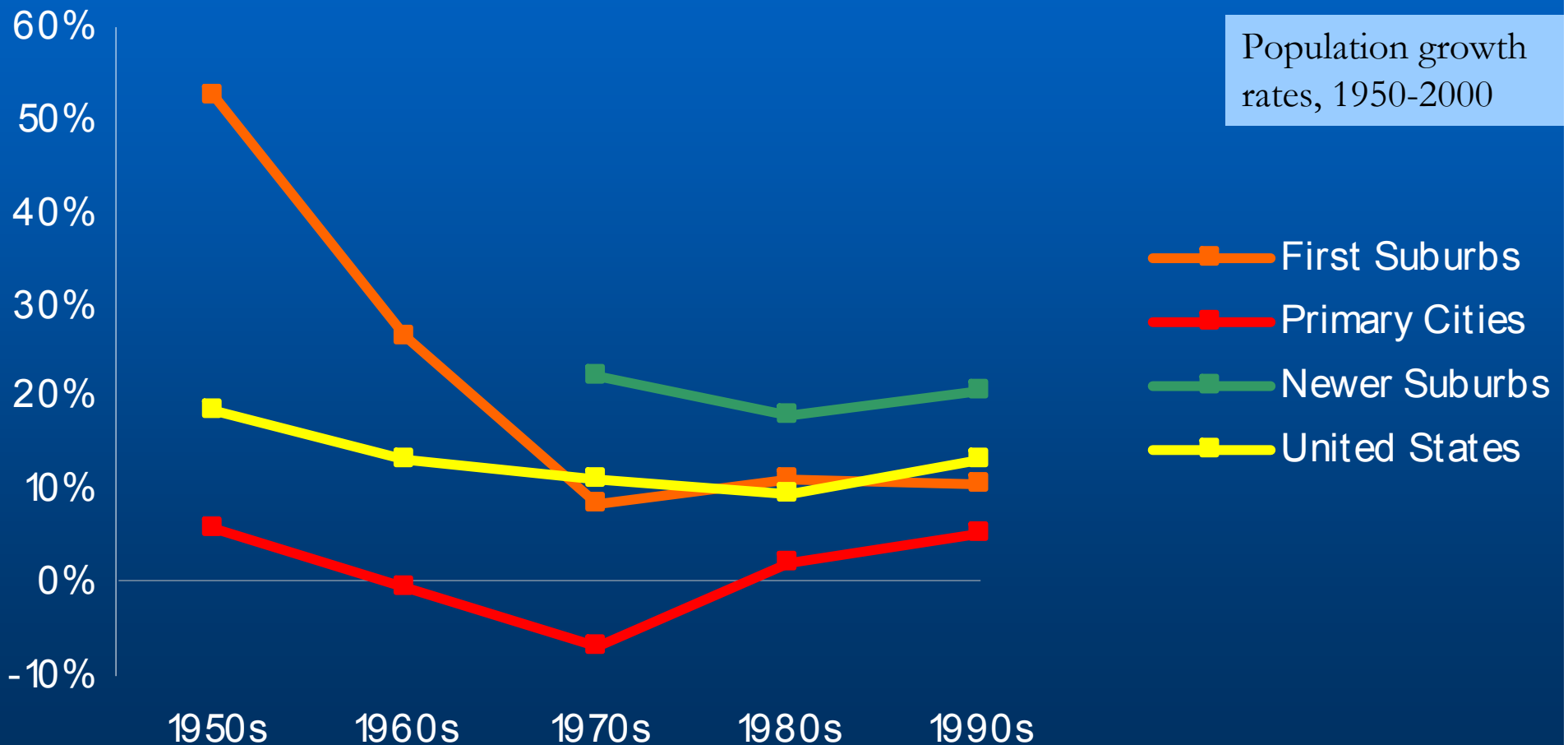

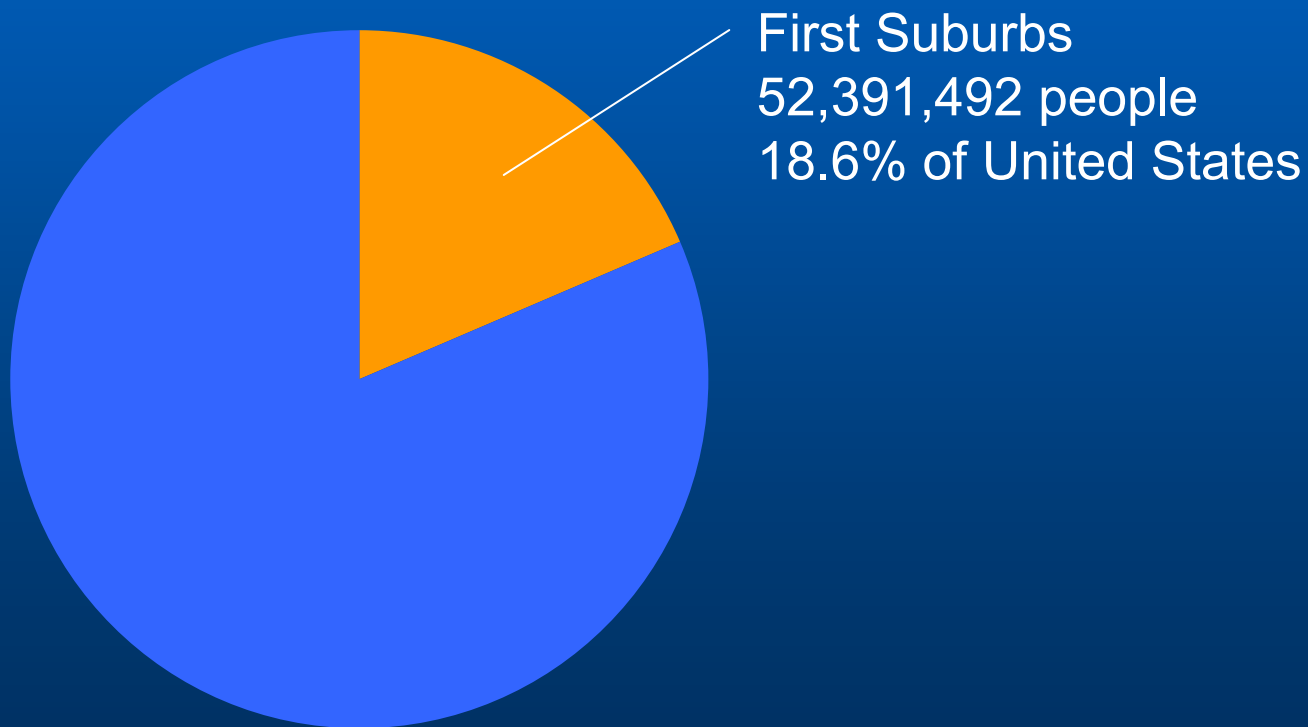
First suburbs have evolved from being fast growing to moderately growing places by the end of the century





By 2000, about one-fifth of the nation's population – 19 percent – lived in first suburbs

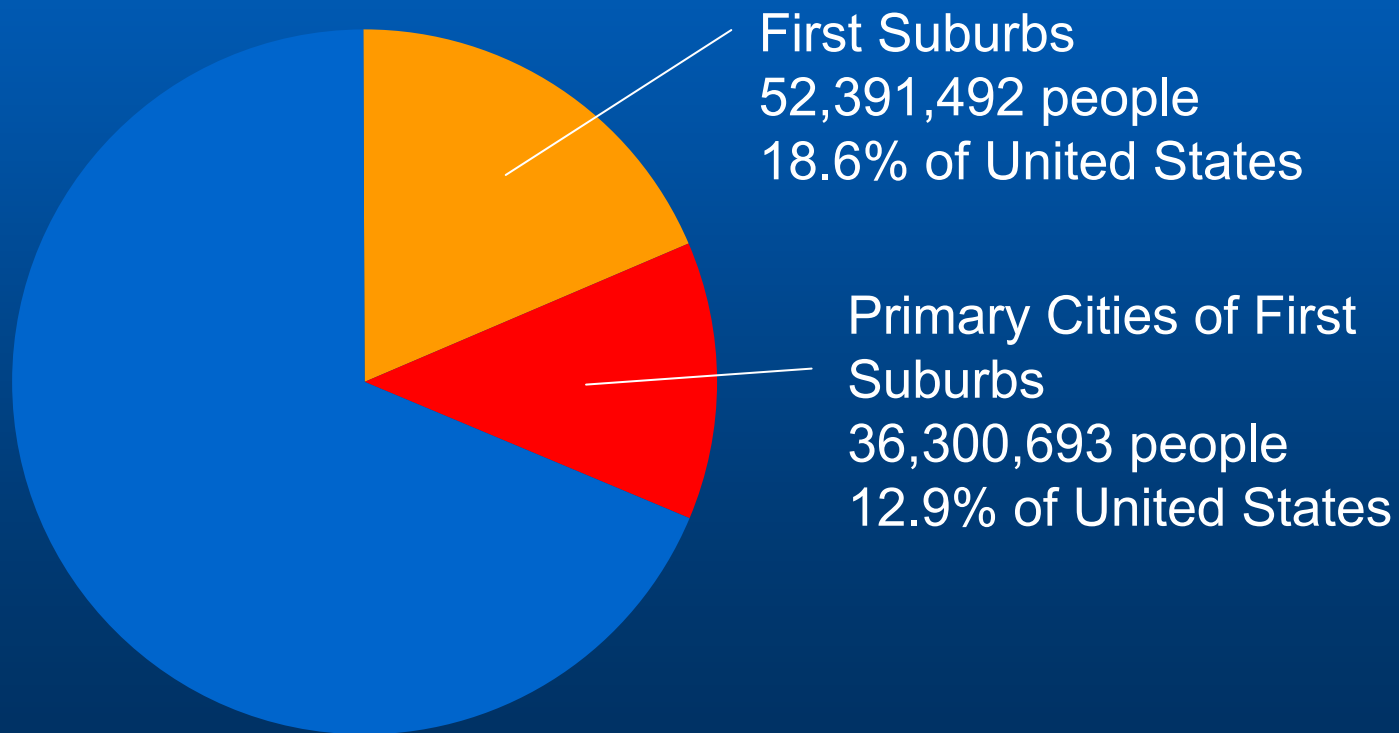
Over 50 million people live in first suburbs





And over 31 percent of the nation lived either in a first suburb or primary city

Almost 90 million people live either in first suburbs or the primary cities of first suburbs





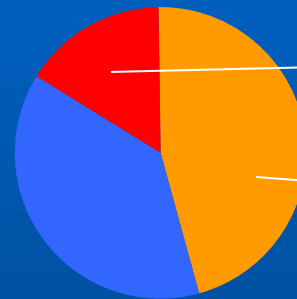
Within states, significant majorities of first suburbs and primary cities could form

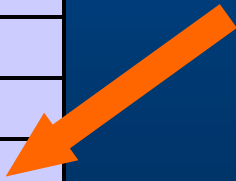

Only 1 of the 10 slowest growing first suburbs has experienced **positive** population growth since 1980

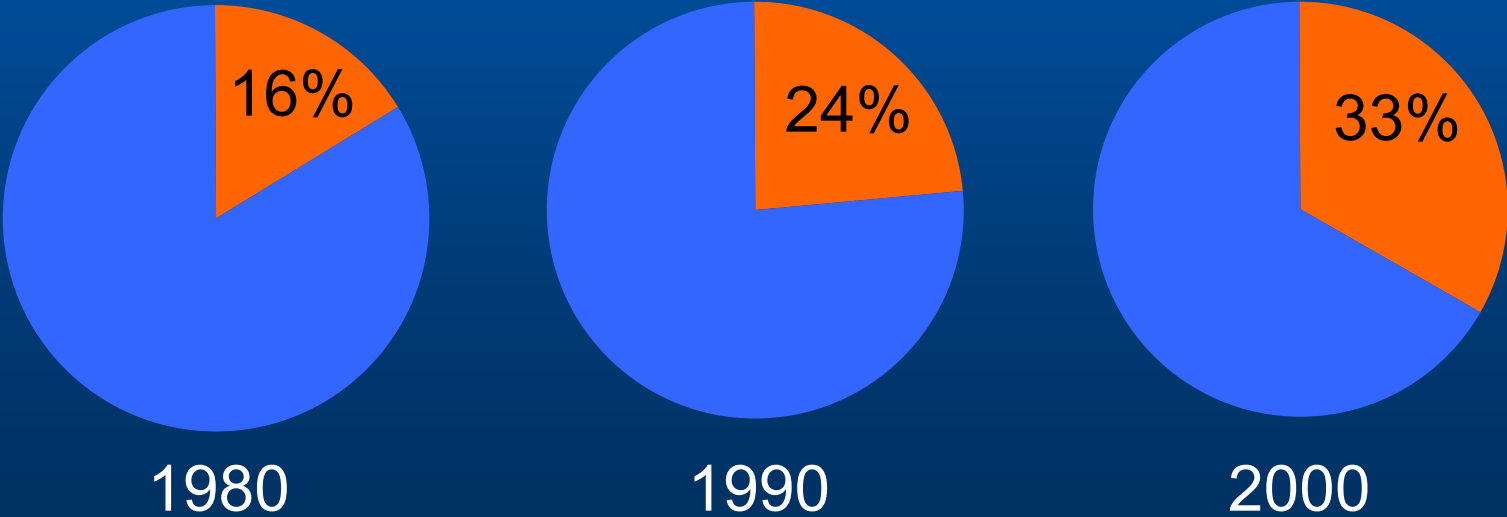




First suburbs went from being less diverse than the nation in 1980 to being more diverse by 2000

■ Racial/Ethnic Minorities ■ Non-Hispanic White





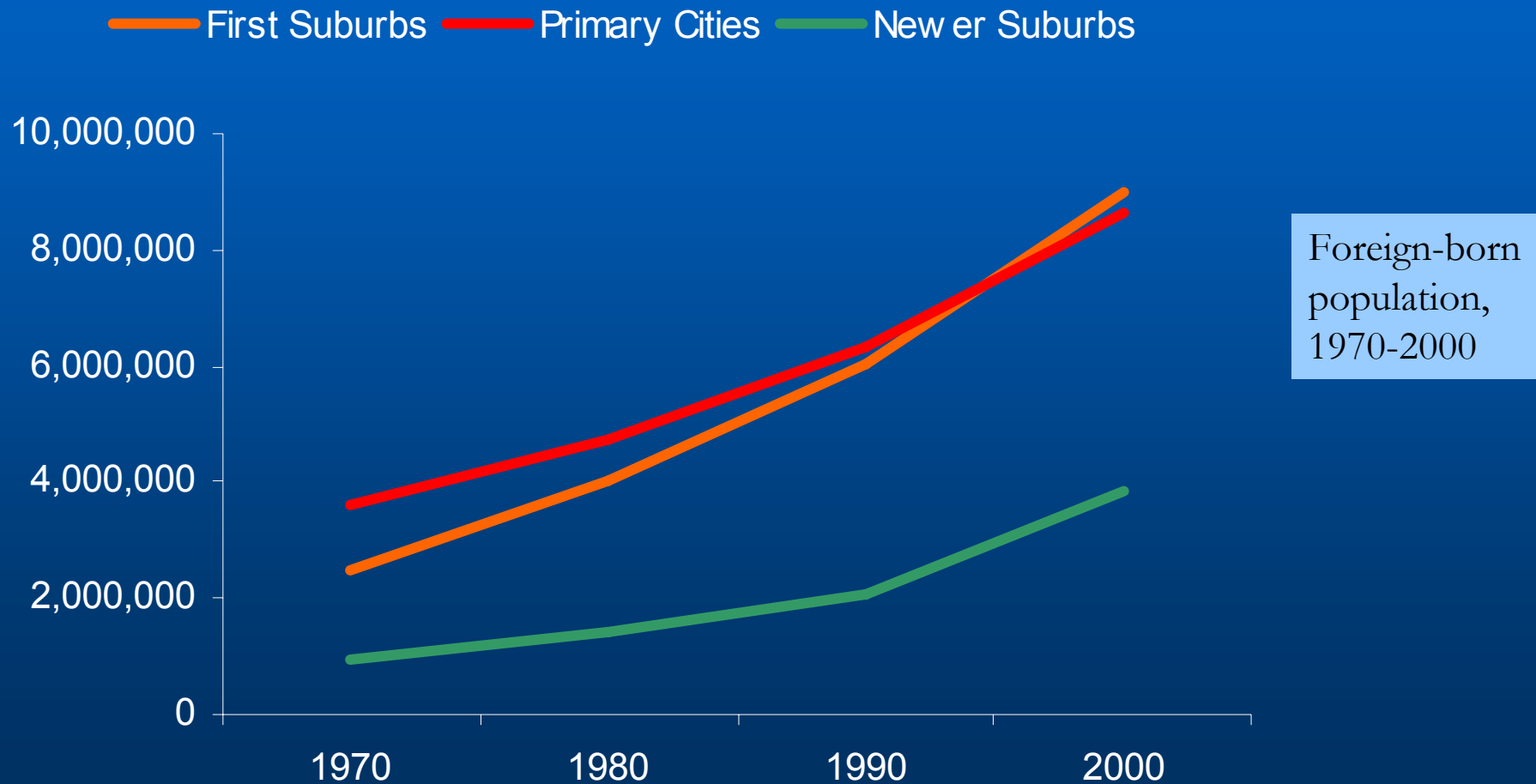
By 2000, one-third of first suburbanites were not white, but this varies significantly across the country

First suburbs are now home to a large and growing number of foreign-born residents





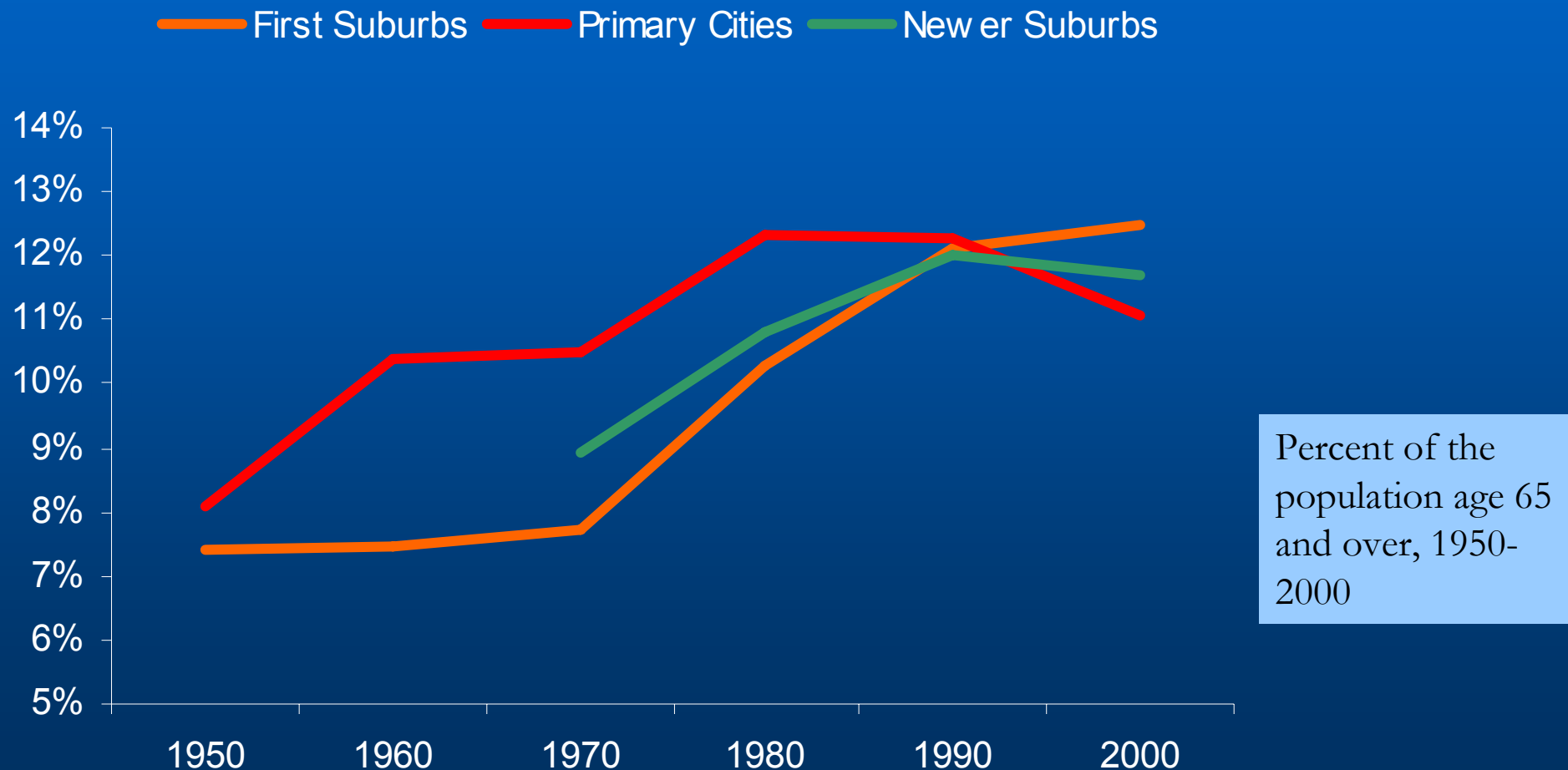
By 2000, over 17 percent of first suburban residents were foreign-born, compared to 11 percent nationally

The percent of elderly in first suburbs is increasing very fast and is now higher than primary cities and newer suburbs





Since 1970, the total number of children barely grew – yet households are still large in first suburbs

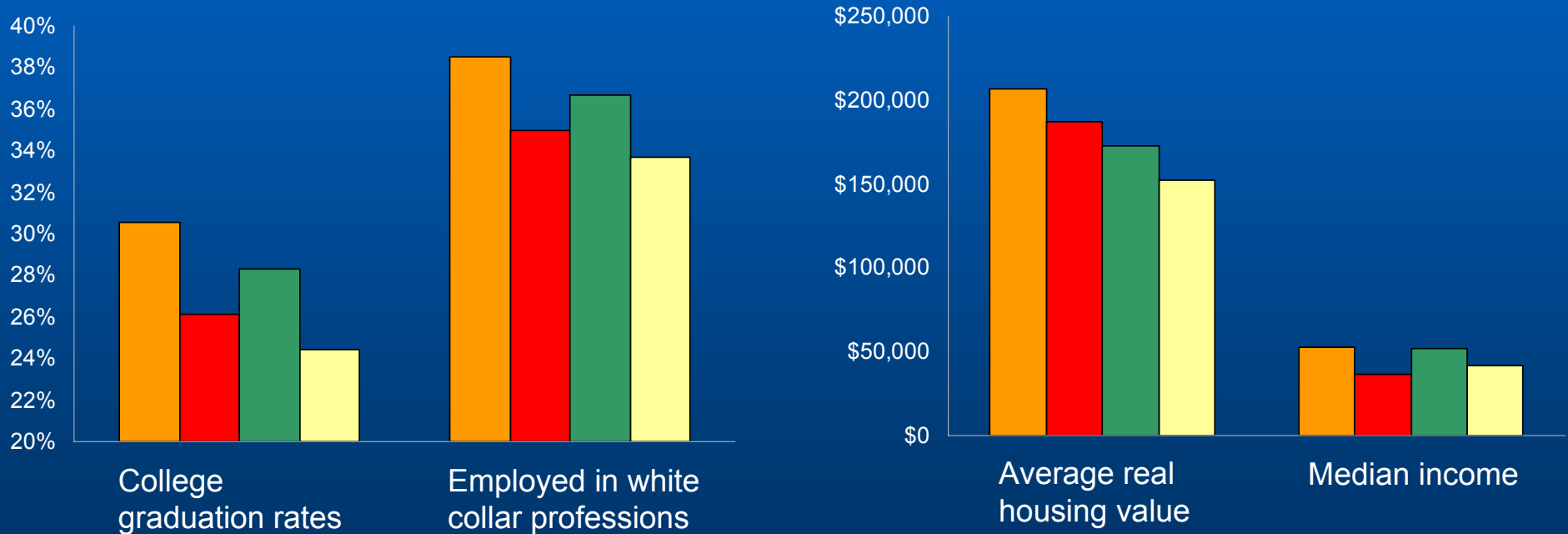
- However, the population of children under 15 is growing very slowly. There are only 190,000 more children in first suburbs than there were 30 years ago
- Yet households are still larger in first suburbs than elsewhere
- Many first suburbs – Dallas, Nassau, King – still have a much higher percentage of their households that are married-with-children than the national average
- Yet the largest increase in household type was female-headed households with children. And the number of so-called “non-families” is greater than any household type



Education, Income, and Employment

First suburbs as a whole have largely retained their position as home to some of the most highly educated and wealthy residents, those with white collar jobs, and highest housing values

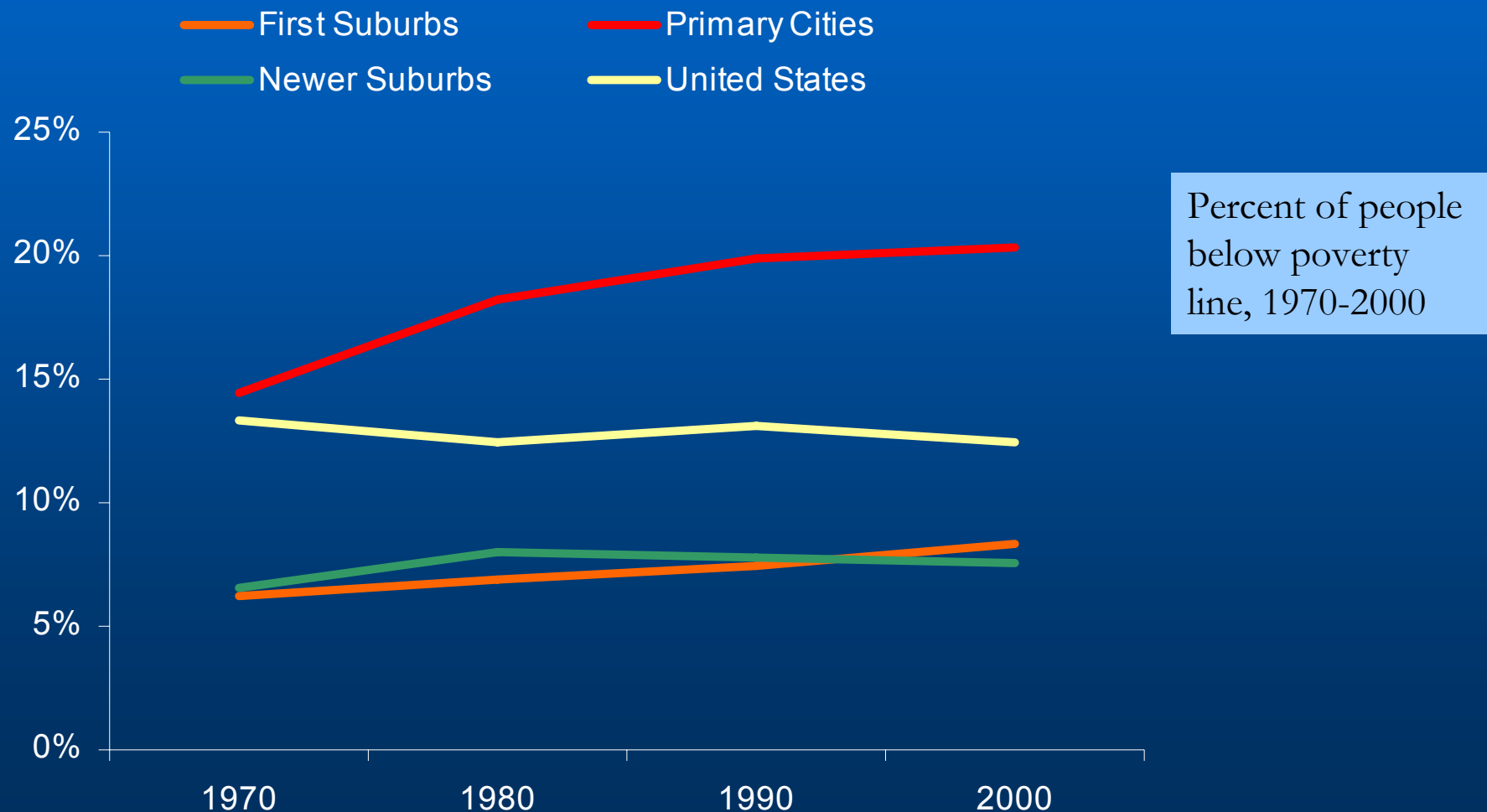

Poverty

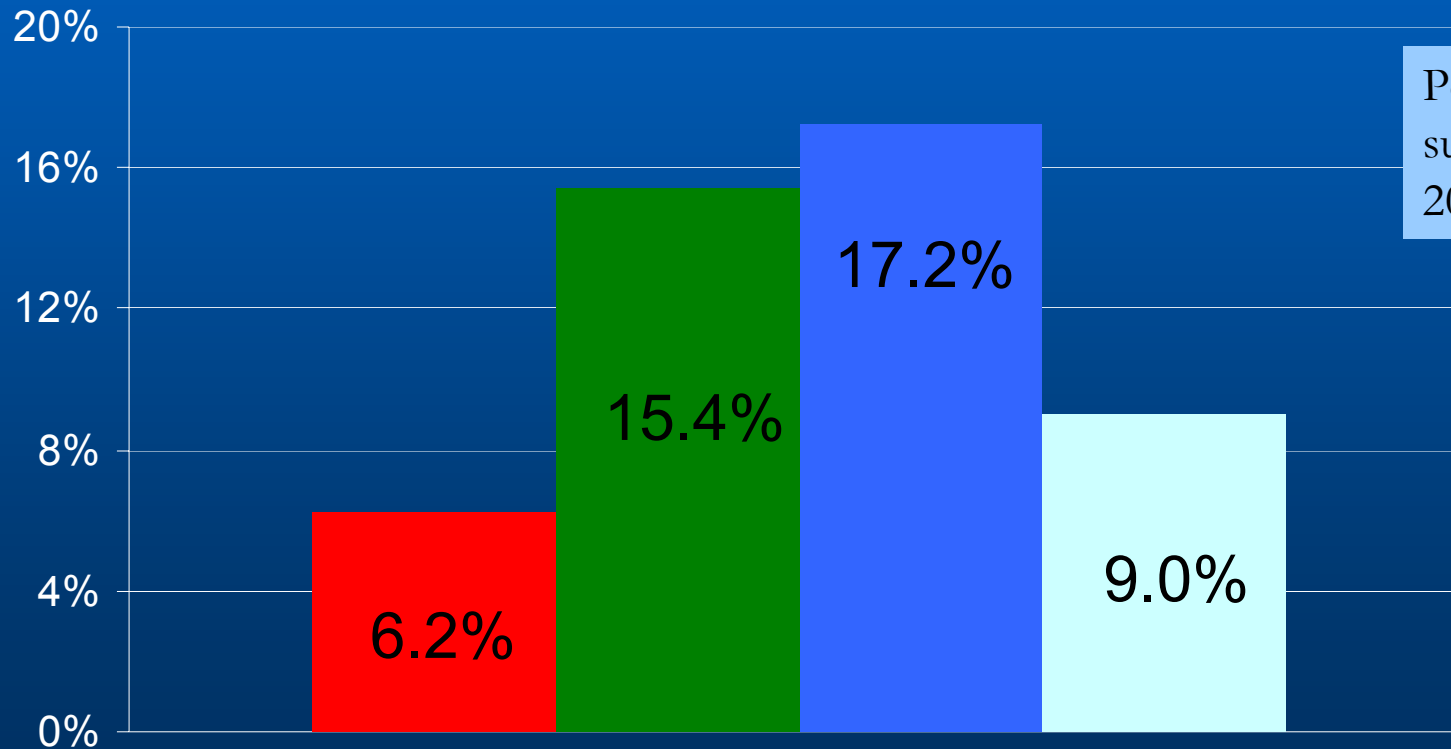
Poverty rates in first suburbs have been steadily rising while the primary cities and the newer suburbs have leveled off or decreased their rates





Poverty rates in first suburbs vary by race and ethnicity; blacks and Hispanics are two and three times more likely to be poor than whites

White Black Hispanic Asian

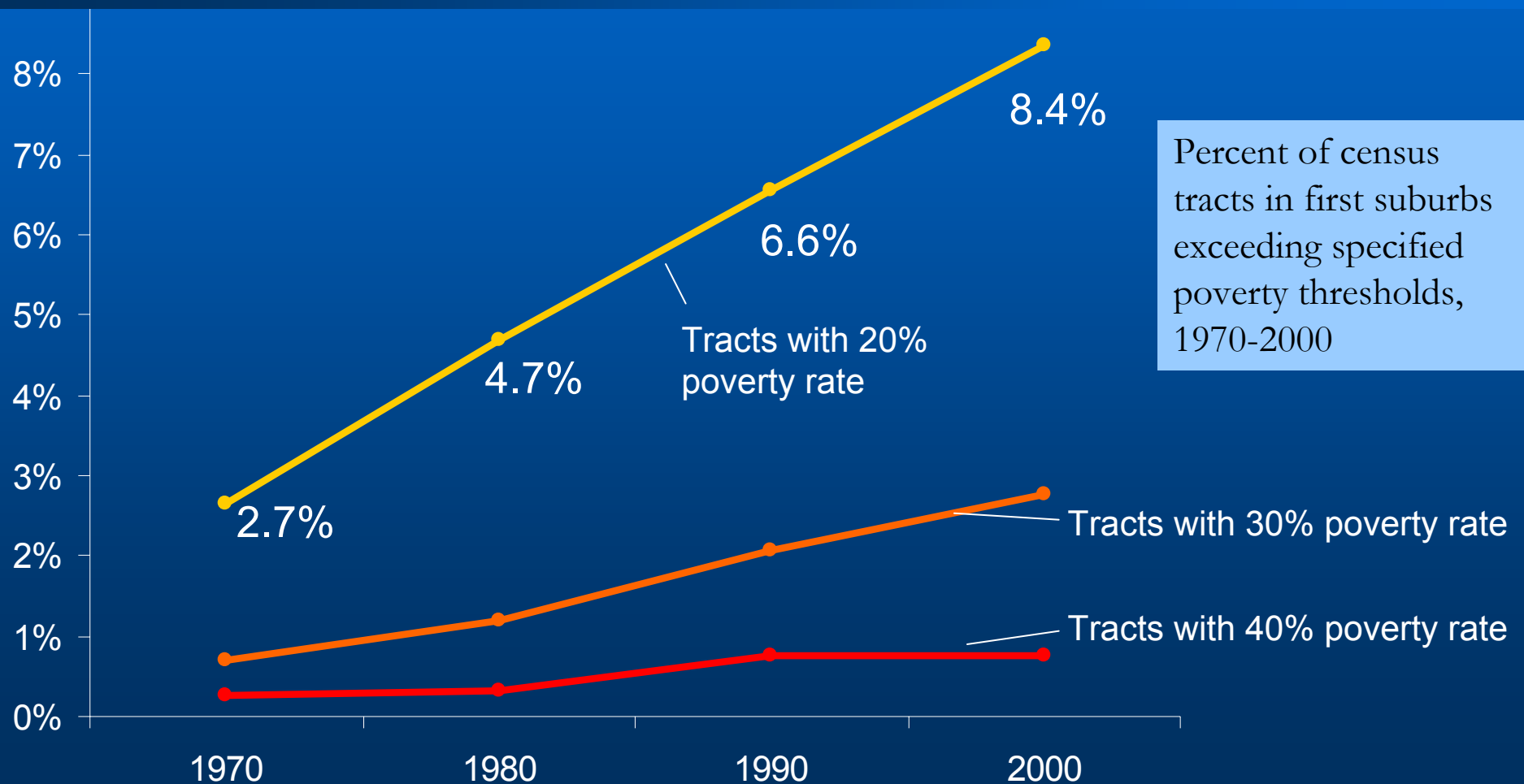


Poverty rate in first suburbs, by race, 2000

Equally disturbing is that while the number of high poverty neighborhoods is dropping sharply in urban areas throughout the country, it is increasing at an alarming rate in first suburbs

First suburbs possess many important assets

1. Home to a large share of the nation's population; likewise in many states
2. Residents are highly educated, wealthy, and employed
3. Convenience and central location
4. Established infrastructure: transportation, water, sewer, schools
5. Potential for collaboration

But it is important to recognize and take seriously a number of critical challenges

1. Uneven population growth
2. Troubling poverty increases
3. Older housing stock
4. Increasing number of elderly and foreign-born populations
5. High level of fragmentation and the “policy blindspot”

A policy framework for first suburbs

- ✓ **ADDRESS THE SPECIAL CHALLENGES OF AN ELDERLY POPULATION:** Requires a continuum of housing responses, as well as coordination between transportation, and health care sectors
- ✓ **MEET THE NEEDS OF THE RISING FOREIGN-BORN POPULATION:** Pursue a set of policies that focus on short term solutions such as language, workforce, and education barriers, but also longer term integration strategies
- ✓ **CREATE AND SUSTAIN ECONOMICALLY-INTEGRATED NEIGHBORHOODS:** Address the rise in concentrated poverty, develop inclusionary zoning programs; expand access to income supports



A policy framework for first suburbs (cont.)



REMAKE AND RENEW THE ECONOMIC AND PHYSICAL LANDSCAPE: Promote private reinvestment; and focus on bold plans that rethink attitudes toward density, urbanity and diversity



PROMOTE REGIONAL COHESION AND COLLABORATION: Form coalitions to push for federal, state, and regional reforms. Collaborate, where possible, on redevelopment efforts
