
## **Births and International Migrants Fuel Population Growth**

From 1990 to 1998, 171,000 more residents moved out of the Washington area to other parts of the country than moved in from the rest of the country. This outward flow of domestic migration reversed in 1998 when 565 more people moved into the area, than moved out. While the Washington area did not attract domestic migrants during most of the 1990s, it more than compensated by attracting 233,000 migrants from foreign countries. The pace of international migration in the Washington area increased from an average 22,000 annually in the first half of the decade to an average of 31,000 in the later years.

The population growth pattern resulting from international and domestic migration varied between

jurisdictions. In the District, Prince George's County, Arlington, and Alexandria the inflow of international migrants did not fully offset the net loss of domestic migrants while the opposite occurred in Fairfax and Montgomery Counties. The outer suburbs gained residents from both domestic and international migrants.

The largest source of population growth in the area was births, not domestic or international immigrations. The 591,000 area births from 1990 to 1998 far exceeded the deaths in the area and resulted in an average natural growth of 40,000 annually. Every area jurisdiction, except the District, had births that were more than twice the number of deaths and in some Virginia suburbs births exceeded deaths by three to five times. In contrast, the Baltimore metropolitan area had a ratio of 1.60 births to deaths compared to 2.55 for the Washington area.

The rapid rate of population growth experienced at the end of the 1990s should continue in the next decade, if domestic migration into the area continues to be positive and international migration continues to increase.
