# 1) Joel Bell

Founding Chairman and President, Chumir Foundation for Ethics in Leadership Joel Bell has been involved in business in Canada, the United States and Europe. Most recently involved in the European mining sector, he earlier founded and served as President and CEO of the Maxlink Group of Companies; was Executive Chairman of Power DirecTV; served as President of a real estate development in Paris; and worked as a business development and financial advisor and executive in natural resources, financial intermediation services, manufacturing and broadcasting. Mr. Bell was also the founding President and Chief Executive Officer of Canada Development Investment Corporation (CDIC).

# 2) Kemal Derviş,

Vice President and Director, Global Economy and Development, Brookings
Kemal Derviş was Executive Head of the UNDP, a member of the Turkish Parliament,
and Minister for Economic Affairs and the Treasury of the Republic of Turkey,
responsible for Turkey's recovery programme after the devastating financial crisis that hit
the country in February 2001. He is a member of the Executive Committee of the
Istanbul Policy Center at Sabanci University and of various Advisory Boards. Mr. Derviş
focuses on global economics, emerging markets, development and international
institutions.

# 3) Homi Kharas

Senior Fellow and Deputy Director, Global Economy and Development, Brookings Formerly a Chief Economist in the East Asia and Pacific Region of the World Bank, Homi Kharas has served as the lead author and executive secretary of the secretariat supporting the High Level Panel, co-chaired by President Sirleaf, President Yudhoyono and Prime Minister Cameron, advising the U.N. Secretary General on the post-2015 development agenda. He currently studies policies and trends influencing developing countries, including aid to poor countries, the emergence of a middle class, the food crisis and global governance and the G20.

Senior Advisor and Research Director, Economics Program, The Conference Board Carol Corrado's primary focus is measuring intangible capital and analyzing innovation and economic growth. She has coauthored key papers on the macroeconomic analysis of intangible investment and capital, including one that won the International Association of Research on Income and Wealth's 2010 Kendrick Prize ("Intangible Capital and U.S. Economic Growth") and one that appears in *Measuring Capital in the New Economy* (University of Chicago Press, 2005), a volume she coedited. Her research on intangibles and innovation has been cited in the popular press, including Business Week, Financial Times, and New York Times. In recent work, she collaborated to develop the INTANInvest database, an internationally comparable dataset of intangible investment and capital for 27 EU countries, Norway, and the United States.

Cozzens' research interests are in science, technology, and innovation policies in developing countries, including issues of equity, equality, and development.
