Across government, senior-level professionals are turning to Brookings Executive Education's [Executive Fellowship](#) program for new ways of thinking, acting and driving results for the American people.

During the nine-month program, participants learn with — and from — a mission-driven cohort that serves as a career-long professional network. The skills they acquire make them more-reflective and successful decision makers, problem solvers and leaders.

The program's research-based curriculum is grouped into five four-day sessions. These sessions prepare fellows to meet the U.S. Office of Personnel Management's Executive Core Qualifications for the Senior Executive Service.

After participants finish their 20 classroom days, they receive Brookings Executive Education's [Certificate in Public Leadership](#). They also can use their fellowship as an on-ramp to the [Master of Science in Leadership](#) (MSL) program. Nine credit hours of fellowship courses can be applied toward the graduate degree.

EXECUTIVE LEADERSHIP FOR AMERICA



The best leaders never stop learning.

This principle guides Brookings Executive Education's hallmark [Executive Leadership for America](#) (ELA) residency. The residency attracts senior-level professionals from a diverse group of government agencies. It also serves as a venue for leadership renewal and re-commitment to public service.

Organizations today are confronted with a world of uncertainty, complexity and ambiguity. For four-and-a-half days, participants discuss common challenges and develop strategies for change. Content focuses on constitutional government, personal resilience, and ways leaders create an emotional bond with their employees.

ELA is designed for public leaders grade GS-15 to the Senior Executive Service. A limited number of GS-14 managers may be admitted, however. By attending ELA, participants can earn [Master of Science in Leadership](#) program credit for the Resilience in Leadership and Motivating People courses.

THE STAR POWER OF PAPERS



Stop, Think, Act, Reflect (STAR): Advanced by Brookings Executive Education, the four-step model improves learning and performance outcomes. The model also serves as the underlying framework for required papers [Master of Science in Leadership](#) students write. These assessments describe how students reduced class concepts to practice.

“Based on a sailing compass, STAR helps participants navigate decision making,” Jackson Nickerson, Professor of Strategy at Washington University in St. Louis’ Business School said. “The model encourages them to pause and reflect on situations from multiple perspectives, and it discourages them from jumping to solutions and solving the wrong problems.”

The reflection component required by the course assessments produces genuine aha moments for participants.

“Think of the written assessments as action-learning projects,” said Fran Johnston, longtime Brookings Executive Education instructor and co-founder of the Teleos Leadership Institute. “The papers establish a cycle of behavior, practice and reflection that makes it more likely participants will continue to apply class content. Consequently, assessments increase the likelihood for successful implementation of new thinking and tools and provide a substantial ROI for the organization.” Consider a senior management consultant at a large domestic agency.

“The assessments made all the difference in my ability to deliver results,” she said. “Applying

class teachings deepened my learning and led to some epiphanies in my understanding of myself, my work and my organization. As a result, the papers serve as a portfolio of my professional successes."
