Note, *Pay or Play and ERISA Section 514*, 10 YALE J. HEALTH POL'Y, L. & ETHICS 197 (2009)

- Because ERISA's broad preemption clause has limited state experimentation in health policy, offered several approaches for statutory modifications to promote greater state flexibility.
- Analyzed preemption under a variety of other federal laws to identify appropriate corollaries.

Note, *Childbearing, Childrearing, and Title VII*, 118 YALE L.J. 1182 (2009)

- Analyzed parental leave policies at 100 large American law firms.
- Argued that many of these policies violated Title VII's prohibition on sex discrimination by granting leave for childrearing (in contrast to childbearing) to women but not men.

FDA Preemption Inputs in Riegel v. Medtronic, 118 YALE L.J. POCKET PART 22 (2008)

- Argued that dicta in a Supreme Court decision interpreting the Medical Device Amendments of 1976 may affect how agencies interpret the preemptive scope of their organic statutes.

- Surveyed state laws creating conservation tax credits and provided taxonomy of policy decisions.
