Next Up in 2019: Insider’s Budget Process



More than an estimate of revenue and expenditures, the federal budget reflects national priorities. Budget decisions affect the size of the U.S. government and the impact of the government on the country’s economy.

Brookings Executive Education provides a window into the federal budget process. Its two-day [Insider’s Budget Process](#) course focuses on the formulation of the president’s budget and the congressional budgeting and appropriations processes. Participants learn how to gauge the effects of policy changes on discretionary and nondiscretionary spending and position their agency effectively during budget deliberations. The class also covers how nongovernmental organizations engage in the budget process.

“Participants need to understand that governing is budgeting, and budgeting is governing,” said Bill Hoagland, senior vice president of the Bipartisan Policy Center and former staff director of the Senate Budget Committee. “During class, I examine real — not theoretical — public-policy challenges faced by legislative decision makers. We also address important fiscal issues like the debt limit and spending caps.”
