The Brookings Institution is a nonprofit public policy organization based in Washington, DC. Our mission is to conduct in-depth research that leads to new ideas for solving problems facing society at the local, national, and global level. Brookings brings together leading experts in government and academia from all over the world who provide the highest quality research, policy recommendations, and analysis on a full range of public policy issues.

In support of Brookings's mission, our scholars host events virtually and in-person. Most events are open to the public to attend or watch online, while others are by invitation only. We welcome guests to our public events and encourage respectful exchanges and discussion. By registering for or attending a Brookings event, you indicate that you agree to our Terms and Conditions of Attendance.

#### REGISTRATION

The Brookings Institution requires advance registration for all in-person events and recommends registration for virtual events. Admittance to in-person events is subject to occupancy limits and available seating. Most in-person events are livestreamed to our website and available to watch online post-event.

Please check the registration confirmation you receive by email for any event-specific instructions.

#### **DECORUM**

We welcome opportunities to offer, observe and discuss differing opinions. However, attendees must comply with requests from staff or security and must refrain from any disruptive behavior that may interfere with others participating, listening or speaking at an event. Brookings is a private institution; trespassing, soliciting, peddling, loitering, and any other behavior deemed inappropriate is not permitted. The distribution of any promotional items such as flyers, handbills, or printed materials is only allowed at the discretion and with explicit permission of the event host(s). Signs, banners, posters, flags, and any similar items that could distract from the event or be used as weapons are strictly prohibited. The Brookings Institution is independent and non-partisan; materials that are of an overtly partisan nature are prohibited.

# BAGS, PERSONAL ITEMS AND SCREENING

For the safety of all attendees, speakers, and staff, all persons, bags, and other containers may be subject to search. Attendees may also be screened by magnetometers (metal detectors) or similar screening and security portals at Brookings's events. Brookings provides coat closets for personal items that require storage during an event; please note that space for storing personal belongings is not guaranteed and Brookings is not responsible for items that are lost, misplaced, or left behind.

# **RECORDING AND PHOTOGRAPHY**

Brookings provides a press box of event audio for media crews. No audio/video devices may be placed on the stage without advance authorization from the <u>Brookings Office of Communications</u>. Brookings reserves the right to disconnect or remove any device which may interfere with an event.

## **GENERAL SECURITY PROVISIONS**

The Brookings Institution reserves the right, in its sole discretion, to deny admission to anyone for any reason and to physically remove from the premises any person(s) in violation of these terms and our standards of conduct.

Any person who is removed from the event may be subject to detention by security for violation of these terms or potential arrest by law enforcement for violation of any applicable laws and regulations.

## **LIABILITY**

By registering for or attending an event, attendees agree that the Brookings Institution assumes no liability for injury, damage, illness, death, property loss or any other loss which may be related in any way to its implementation of this policy. In the event of injury, illness, or accident during a live event or program, attendees consent to have medical treatment that may be deemed advisable and affirmatively releases the Brookings Institution and any and all persons participating in such medical treatment from all responsibility for any such action.

The Brookings Institution regularly records programs and special events. By confirming your participation in the event as a speaker, panelist, presenter, invited guest or a member of the public attending the event in-person or virtually, you acknowledge that the Brookings Institution may record, livestream, and/or share the content publicly during and following the event. You also acknowledge that the Brookings Institution and its designees maintain the right to include your image, likeness, voice, actions, and statements, or other documents or information in any live or recorded audio, video, film, webinar, stream, or other transmission, simulcast, or reproduction made of, or at, the program in any medium or context for any purpose, including commercial or promotional purposes, without further authorization or otherwise, now and forever.
