Conflict of Interest Disclosure Policy for Outside Contributors

The Brookings Institution is a nonprofit, nonpartisan public policy organization committed to undertaking and disseminating rigorous, independent and impartial policy research. Outside contributors – individuals other than Brookings employees and affiliates – from whom we invite or otherwise solicit work are expected to adhere to and uphold these core values, and not act in ways that might compromise their reputation or reflect negatively on the Institution.

Outside contributors are not permitted to submit work if such work would pose, or appear to pose, a conflict of interest for either the outside contributor or Brookings. In addition, submissions by outside contributors must be original works of authorship; must not infringe on or otherwise appropriate another party's intellectual property; must not violate applicable laws such as (but not limited to) those relating to privacy rights and defamation; and must otherwise comply with Brookings policies and any applicable research ethics requirements. Outside contributors may not offer, and individuals employed by or otherwise affiliated with Brookings may not request, any compensation, gift, favor, or anything of else of value in exchange for publication on the Brookings platform.

In support of this policy and as an integral part of the Institution's quality review process, outside contributors are required to complete the attached acknowledgement and disclosure form when submitting work for publication to Brookings, regardless of the submission's length or whether it is exclusively authored by the outside contributor or co-authored with a Brookings scholar. Outside contributors must provide complete and accurate answers to each question, and should err on the side of disclosure if uncertain as to whether an answer should be included.

Disclosure of outside activities and interests advances transparency and the collective fulfillment of Brookings' independence and integrity policies; disclosure of a response does *not* invariably suggest a conflict of interest. Brookings will store and review the provided information to determine in its discretion whether a conflict of interest exists or might appear to exist, and what disclosures and/or other steps may be required to avoid or manage such conflict(s). To promote transparency, relevant interests or activities may be disclosed to the public on content published on Brookings platforms.
