



50 Years of EITC Trends




- Billions of Total EITC Benefits (2025 \$), Left Axis

- ---- Avg EITC Benefits Per Recipient (2025 \$), Right Axis


The Original 1975 EITC vs the EITC Today





The EITC Today, by Number of Kids and Marital Status





Maximum EITC Benefits by Number of Kids, Over Time





























































































Max State + Federal EITC by Number of Kids, Over Time

- 3 local EITCs: NYC, SF, and Montgomery County MD


How to Estimate Impact of EITC on Various Outcomes?

- Much policy variation: by year, number of kids, marital status, state
- How to estimate causal effects? Many options, including:
 - Binary difference-in-differences (DD), continuous DD (e.g., *MaxEITC*) to better capture size of policy changes, etc.


How to Estimate Impact of EITC on Various Outcomes?

- Much policy variation: by year, number of kids, marital status, state
- How to estimate causal effects? Many options, including:
 - Binary difference-in-differences (DD), continuous DD (e.g., *MaxEITC*) to better capture size of policy changes, etc.
- How many years to consider after a policy change?
 - Takes people up to 4–5 years to respond to EITC policy changes
 - 1975 EITC expansion lead to an increase in employment through 1979
 - 1993–1996 EITC expansions lead to an increase in employment through 2000


1975 EITC & Employment of (Mostly Unmarried) Mothers




1990s EITC Expansion & Employment of Unmarried Moms

- Extensive margin, not intensive margin (Meyer, 2002)
- Effects largest among unmarried, younger, lower-education, younger kids, rural mothers
- Similar effects across race/ethnicity, but varies by specification (Hardy and Ziliak, 2022)
- Small negative effect on married mothers (Eissa and Hoynes, 2004; Bastian and Jones, 2021)

EITC and Labor Supply: Survey of the Literature

- Kleven (2018–2024) and Looney (2024) cast doubt on EITC's employment effects
- Mead (2014; 2018) also argued this point in qualitative work
- Bastian and Jones (2021) and Kuka and Shenhav (2020) address Kleven indirectly
- Schanzenbach and Strain (2021) address Kleven directly

EITC Impacts Income and (Very Likely) Labor Supply

• Since income affects many many things, this means the EITC may also impact many other short-run and long-run outcomes

The EITC Helps "Pay for Itself"

- By increasing labor supply and income, the EITC increases the taxes households pay and reduces the government transfer payments they receive, offsetting the EITC's cost
- Bastian and Jones (2021) find that the EITC's net cost is only 17% of the (\$70 billion or so) budgetary cost
- On net, the EITC is actually one of the U.S.'s least expensive anti-poverty programs
- If you consider the public value of other effects (e.g., reduced crime, improved health, intergenerational outcomes) then EITC expansions completely pay for themselves
